Executive Summary

The California Coalition for Mental Health (CCMH) is a diverse, broad-based coalition of statewide associations and organizations who seek to improve the delivery of mental health care in California, with a focus on creating better access to care and assuring parity in the delivery of mental health services that is on par with other health care services. CCMH coalesced around Proposition 63 in 2004, the landmark initiative that significantly bolstered funding of mental health programs through a one-percent tax on individual income over \$1 million. One of our core commitments is to ensure adequate funding for mental health programs and care.

Priority areas for 2023 included: <u>housing, parity and workforce</u>. These priorities guided state and federal legislative and policy analysis, recommendations and advocacy. Through quarterly meetings, virtual work sessions, and meetings with state leadership CCMH members discussed/informed the following:

- Implementing 988 and a Robust Crisis Care Continuum in California (Appendix H)
- Behavioral Health Workforce (See Appendix C, D, E and G)
- Behavioral Health Modernization / Behavioral Health Services Act Initiatives
- Increasing Parity through the "Better Mental Health Care for Americans Act"

Long-Standing Barriers & Concerns: CCMH also engaged in discussions with California's Health and Human Services Administration and Mental Health Oversight and Accountability Commission leadership, focusing on long-standing barriers and concerns (See Appendix B).

BHSA & BHIBA: Due to major initiatives that may change the Mental Health Services Act (through the March 2024 "Proposition 1" ballot initiative), CCMH also focused on informing these initiatives: SB 326, the Behavioral Health Services Act (BHSA) legislation and AB 531, Behavioral Health Infrastructure Bond Act (BHIBA) legislation.

Safeguarding Funding: Historically, mental health programs are among the first to be cut when California faces economic challenges. This trend leads to a chronically underfunded system. As we move into 2024, CCMH will continue to work to safeguard mental health care funding and support budget decisions that strengthen the delivery of mental health services throughout California.
