Friday, January 18th

8:30 am: Behavioral Health "Planning Council" General Session: CALBHB/C Governing Board Members and members from Southern Region local mental/behavioral health boards and commissions, attended the Planning Council meeting from 8:30am until noon.

8:40am: CALBHB/C Report to the Planning Council: Executive Director, Theresa Comstock 1) Thanked CBHPC staff and members, specifically:

- a. 2018 new legislation summaries (Naomi)
- b. Public Charge communication (Naomi)
- c. Approving WET 5-year Plan (CBHPC)
- d. Planning Council members who have informed CALBHB/C regarding their areas of expertise, including: Noel O'Neill, Kathi Mowers-Moore, and Monica Nepomuceno
- 2) Reviewed top issues CALBHB/C is hearing from local boards/commissions. Top issue is supportive housing/Adult Residential Facilities. Other issues mentioned: Workforce, Jail/5150 Mgmt, Schools/Children, increasing Crisis Stabilization Units, Psychiatric Inpatient Bed Shortage.
- 3) Noted CALBHB/C's Principles for Support & Advocacy document, specifically: Item 1) Community Input CALBHB/C is supporting this with increased training, communication and support.
 - Item 2) Performance Data Especially the need for data showing local impact of services.
- 4) CALBHB/C is increasing its presence in Sacramento/statewide, to include
 - a. Beginning and/or exploring involvement with many statewide coalitions.
 - b. Increased collaboration/communication with statewide allies, including partnering with NAMI CA for cultural competency training and Capitol Day
 - c. Additionally CALBHB/C Executive Director Theresa Comstock is an appointed member of the CA State Rehabilitation Council that advises the Department of Rehabilitation
- 5) CALBHB/C is scheduling increased training for mental/behavioral health boards/commissions to address: Community Program Planning and Cultural Competency.

Call to Order: The meeting was called to order by President, Benny Benavidez and introductions were made by attendees.

1:20pm: CA Behavioral Health Planning Council's report on current activities:

Jane Adcock, Planning Council Executive Officer reported:

- WET 5-year Workforce Plan had been approved by the Council and stakeholders can advocate for funding
- The new rules in the "Bagley-Keene Act", that CBHPC follows, no longer allow conference calls for committees (a majority must be present at physical location)

Susan Wilson, CA Behavioral Health Planning Council member and Liaison to CALBHB/C reported on the Data Notebook. The 2018 Data Notebook was sent out to all 59 MH/BH Boards & Commissions and is due March 31, 2019. The next Data Notebook may include Trauma Informed Care.

3:15pm: Mental/Behavioral Health Regional/Statewide Issues/Successes – Items shared included:

- 1. A peer respite facility in Santa Cruz was going to close and the community advocated so were able to keep open.
- 2. Orange County received 90 million for housing from CSS funds.
- **3.** L. A. counties and cities are rebidding housing contracts.
- **4.** In Imperial County, a 5150 Ad Hoc Committee has formed to recommend improvements to system of care for 5150 management. First step will include data collection from different agencies with the help of consultants (RDA). Stakeholders are involved in this process.
- **5.** Yolo County opened new housing (20 apartments) for homeless with mental illness.

Open Comment for Governing Board Members/Public: President, Benny Benavidez thanked our new Executive Director, Theresa Comstock, for all the work she has been doing connecting with counties and statewide coalitions on behalf of CALBHB/C. Mae Sherman, Secretary/Treasurer, was also thanked as well as all the Governing Board members for the work they are doing.

Member Jerry Harris had provided a memo detailing recommendations in many areas, including: Annual Goals, Role of Governing Board Members, Focus on Issues, and Communications. (These items were discussed during corresponding agenda items during the meeting.)

Approval of Minutes: The minutes from the December 17, 2018 teleconference meeting were presented for approval. A motion was made by James Glica-Hernandez to approve the December minutes with a second from Alisa Chatprapachai. Larry Lue abstained. Motion carried.

Financial Report: Executive Director, Theresa Comstock reviewed current financials. A dues reminder was recently sent to those counties who haven't yet paid. Current assets as of January 12, 2019 is \$148,276.80. A motion to approve the Financial Report was made by James Glica-Hernandez with a second from Lynda Kaufmann. Motion carried unanimously

President's Report: President Benny Benavidez asked the Governing Board to approve the appointment of Supervisor Stacy Corless (Mono County) as a Central Region Governing Board member. Supervisor Corless is entering her second term in office and served as Executive Director of Education & Conservation, focused on nonprofits. She also has served on the Mono County Behavioral Health Advisory Board since 2015. Supervisor John Fenley made a motion to approve the appointment, and Stacy Dalgleish seconded the motion. The motion passed unanimously.

CALBHB/C's 2019-20 Annual Goals (Draft) After discussion, a motion to approve the <u>2019-20 Annual Goals</u> was made by James Glica-Hernandez with a second from Stacy Dalgleish. Motion carried unanimously.

Regional Outreach Update: Discussion on regional outreach, teleconferences and MH/BH board visits. Counties can report issues and successes on CALBHB/C's web page. All 59 Counties have been invited to participate in teleconference calls. Some of the counties in Bay, Central, Superior, and Southern have attended so far with more to come in February, March, & April. Overall, the teleconferences have been very well received, and have facilitated increased sharing of resources and issues. Teleconference minutes were provided in the meeting packet.

Executive Director's Report:

- 1. Facilitating Officer Nominations for 2019-20: An Ad Hoc committee has formed to nominate officers (President, VP and Secty-Treasurer) for election at the Annual Meeting in April. Supervisor, John Fenley is the chair, with Alisa Chatprapachai, James Glica-Hernandez, Stacy Dalgleish and Harriette Stevens also serving as committee members.
