## CA Association of Local Behavioral Health Boards & Commissions (CALBHB/C) Minutes of Governing Board Meeting May 18, 2018, 7pm (Go-To-Meeting Conference Call)

Alisa Chatprapachai reported that the Orange Co. Behavioral Director provides written reports to the Behavioral Health board members prior to their meeting to better allow the board to discuss issues.

The minutes of April 20, 2018 meeting and training in Redwood City was presented for approval: The minutes were sent electronically to Governing Board members prior to the meeting. After a lengthy discussion, a motion was made by Benny Benavidez to accept the proposed changes (*see attachment*) with a second from Harriette Stevens. The motion carried unanimously.

President Theresa Comstock encouraged Governing Board members to reach out to local boards in each of their regions:

- 2. To ask about local board/commission needs (such as resources and training needs).
