Analyzing disparities in network use and provider reimbursement rates in California

OVERVIEW OF MILLIMAN REPORT AND NATIONAL FINDINGS

A national study by the Milliman Group revealed that out-of-network use of behavioral health care services was significantly higher than medical/ surgical out-of-network utilization, and physical health care providers routinely receive significantly higher payment from insurers for the same type of services. This data presents a stark picture of restricted access to affordable mental health and substance use treatment in an era of escalating suicide rates and opioid overdose deaths.
