Dear Dr. Pfeifer, Dr. Ewing, Chair Ashbeck, and MHSOAC Members,

We write to formally ask that DHCS and MHSOAC establish a standardized set of MHSOAC performance outcome data points to facilitate effective reporting by CA's 59 local mental/behavioral health (LMBH) agencies, thereby allowing effective review and comment by CA's 59 LMBH boards and commissions. It is in the best interest of CA's local communities to know the impact of MHSOAC-funded offerings.

We call attention to CA law (WIC 5848(c)) that specifies performance outcome data responsibilities of DHCS and MHSOAC in collaboration with County Behavioral Health Directors Association of CA (CBHDA) and with the review and approval of the CA Behavioral Health Planning Council (CBHPC) (WIC 5772(c)(3)). Further, WIC 5604.2(a)(7) specifies the duty of each of CA's 59 LMBH boards and commissions to review and comment on performance outcome data.

To increase review in the short-term, CALBHB/C identified and now provides existing performance outcome data from each of the 59 local MH/BH agencies (MHSOAC, Medi-Cal EQRO and SAMHSOAC PATH) at [www.calbhbc.org/performance](http://www.calbhbc.org/performance). There is good performance outcome information in some counties, although it is quite evident that DHCS and MHSOAC (with input from CBHDA and CBHPC) should standardize data points and reporting requirements, along with facilitating analysis and communication.

We urge DHCS and MHSOAC to prioritize this important work.
