Panelist Bios:

Andi Mudryk is the 2020 Governor appointed and unanimously confirmed by the California Senate in April 2021, the Chief Deputy Director of the California Department of Rehabilitation (DOR). Andi joined DOR in 2018 as the Chief Counsel. The DOR provides services and advocacy resulting in employment, independent living, and equality for individuals with disabilities.

Before joining DOR, Andi served as the Deputy Director of Disability Rights California, which is the largest disability rights law firm in the country and the largest legal services provider in California. She graduated with honors in 1989 from the George Washington University Law School in Washington, D.C. and has extensive experience serving in leadership roles in non-profit organizations and in litigating a variety of discrimination and disability-related claims. She is admitted to practice law in California, Arizona, and Michigan. On a personal note, Andi is a proud transgender woman with Osteogenesis Imperfecta (OI), also known as Brittle Bone Disorder.

Dante Allen is the Executive Director of CalABLE Act Board and is responsible for program operations of the State of California's savings and investment program for people with disabilities. Prior to joining CalABLE, he served as the Communications Officer for the California Department of Public Health's Office of Health Equity where he developed strategies to promote the concepts related to the social determinants of health. He also served as the Communications Director for the President and Chief Operations Officer of Kaiser Permanente, the nation's largest health plan and hospital system. Dante also serves on the Board of Directors for Resources for Independent Living, Sacramento, and the Crocker Art Museum. He holds his undergraduate degree from the University of California at Davis and a master's degree from the University of Southern California's Annenberg School of Journalism and Communication. Dante was born with a form of spina bifida, a congenital condition that caused partial paralysis requiring him to use a wheelchair. He enjoys outdoor activities including swimming, wheelchair basketball and skiing. He is also the proud parent of a teenage daughter

Scott Allen works in the Assistant Director of the Office of Legislative Affairs with the state Department of Child Support Services (DCSS). He has been with the (DCSS) since 2015 as a Legislative Analyst. Scott helps write and develop the department's legislative analyses and legislative proposals and leads DCSS's annual bill analysis/legislative process training. Scott holds an undergraduate and graduate degree in Government from California State University Sacramento. He is a loyal northern California sports franchise fan. In his spare time, he enjoys family, friends, staying up late listening to Queen, watching horror movies, and pretending to be a rock drummer. Scott wanted to participate in the discussion and highlight mental health disabilities including his own experience dealing with PTSD, anxiety, and depression.
